

## Subsidised Pest Control Products

### Introduction

This Environment Topic outlines the materials available for landowners carrying out animal pest control work on their own properties.

### What products are subsidised?

As part of the Regional Pest Management Strategy, subsidised pest control products are available to all rural and urban ratepayers of Hawke's Bay.

The Regional Council does not endorse any particular products, manufacturers or companies but over the page is a list of the range of products available. All products are subsidised by 50%.

Subsidised pest control products are available from all Hawke's Bay branches of Farmlands Trading Ltd and PGG Wrightson Ltd.

Some subsidised pest products are subject to availability within stores. Those subsidised products not available can be sought from suppliers when specifically required.

### Do I need a licence?

The majority of subsidised products and traps do not require licences to use them. Users must however follow instructions provided by the manufacturers. In particular some products can only be used in bait stations.

Licences are required for a range of control products. Such products cannot be purchased without a license and can only be used by license holders or under the direct supervision of a license holder.

### What advice and information is available?

The Regional Council's Biosecurity Advisory Team can provide advice and information on all subsidised pest control products. Staff can also assist with training on the use of equipment and products for landowners. The contact details of pest control contractors are also available for those that prefer to hire a contractor to undertake pest control work.
