

Ngaruroro Trigger Flow

- The status quo trigger flow of 2400l/sec at Fernhill for restricting takes and managing any future flow enhancement schemes be adopted for the Ngaruroro River and
- Council makes a commitment to better understanding state and trends of the indigenous fishery. HBRC will seek DOC assistance and Mana whenua input in managing this work through the implementation plan.

Tutaekurī Trigger Flow

- The status quo trigger flow of 2000l/sec at Puketapu for restricting takes and managing any future flow enhancement schemes be adopted for the Tutaekuri River and
- 2. No further water is allocated for abstraction from the Tutaekuri there is still some unallocated water within the current allocation limit.
- 3. The default allocation for abstraction from the Mangaone and Mangatutu be set at 10% of the MALF as a default interim measure
- 4. Council makes a commitment to better understanding state and trends of the indigenous fishery. HBRC will seek DOC assistance and Mana whenua input in managing this work through the implementation plan
