Description

To discharge secondary treated domestic effluent from a three bedroom dwelling into the ground in circumstances where contaminants (or any other contaminants emanating as a result of natural processes from those contaminants) may enter water

To install a 62m double span bridge in the bed of the Kikowhero Stream that may be restricted by section 13 of the RMA

To discharge cleanfill within 20m of the Kikowhero Stream River in circumstances where contaminants (or any other contaminants emanating as a result of natural processes from those contaminants) may enter water and may be restricted by Section 15 of the RMA

To temporarily divert the Kikowhero Stream

To clear vegetation and disturb soil within 5m of the Kikowhero Stream

To drill bore 17553 (125mm diameter) for waste disposal

to erect a bridge over the bed of Ongaru Drain and to undertake other activities directly associated with the construction of a bridge that may be restricted by Section 13 of the RMA.

To undertake earthworks in circumstances where cleanfill will be discharged within 20m of a waterway.
