

# Application for Resource Consents

AUTH-127078-01	Discharge to Air - Burnside Road, Takapau	To discharge to air (odour) from the management and discharge of wastewater at the Takapau Wastewater Treatment Plant and land application system
AUTH-127079-01	Discharge to Land - Burnside Road, Takapau	To discharge treated sewage effluent from the Takapau oxidation pond onto land in circumstances where contaminants (or any other contaminants emanating as a result of natural processes from those contaminants) may enter water
AUTH-127077-01	Discharge to Water - Takapau Oxidation Pond, Burnside Road, Takapau	to discharge treated sewage effluent from the Takapau oxidation pond into or onto land through a land passage system in circumstances where contaminants (or any other contaminants emanating as a result of natural processes from those contaminants) may enter water
AUTH-127616-01	Production Land Use - Burnside Road, Takapau	to operate a farm not complying with activity standards of Rule TT1 and TT2
